

3. To open service facilities for Every Teaching/Non-Teaching Staff appointing in the School as per Government Notification Number:- ED 104 SEP 2005 dated:- 12/01/2006 and to record the service details therein in pursuant to the rules and to maintain the same.
4. Must provide necessary accommodation, tables, furnitures, teaching apparatus and play ground, minimum basic facilities to run School.
5. As per Government Order Number: ED 59 MULTI 99, dated: 2/2/2000 Article-4, Rule-3, the Scholl shall have admission of students, attendance.
6. To recover fees only as per Departmental Rules and to maintain accounts and keep in the name of the School and to produce during school investigation. Accounts upto the previous year must be filed to the Registrar and must file acknowledgment copy.
7. As per Karnataka Education Code Rules, permanent fund deposit must be kept.
8. Must teach textbook decided by the Department. Must follow Language Code in English Medium Schools. Without obtaining prior permission of Department, should not open extra Class/Sections.
9. Staircases required to go to the floors above the School should not be narrow. In case, safety walls are not constructed in each floors, or if very small walls are constructed, in this regard, very much urgent action should be taken up. Should lookater that Atleast 5 feet retention wall should possess. Grills must be installed so as not to cause obstruction for air and light system.
10. To provide all necessary actions and basic facilities regarding safety of children as informed in Karnataka Education Institutions (Classification, Regularization and Fixation of Curriculum, etc.) Rules, 1995.
11. While sending the students going to the Class after the prayer there must be arrangement to avoid overcrowd of children going to the upper floor. The

same arrangement must be there when the school is left and after last bell is rang. Security Guards of School must be deployed for this work.

12. If there are circumstances of the students of school crossing the roads after finished the school in any event, either the Teacher or Security of Management must be present compulsorily. Arrangement must be made to cross the children.

13. Already several times in Vehicles carrying and bringing the children must prohibiting overloading the children exceeding the fixed numbers and violating the Transport rules. In case the Management do not have control over the Transport System, must give complaint to the Police Department regarding prohibited cases.

14. In the events of quitting or leaving the school during midterm period or for exceptional reasons, must take up action keeping watch on movements of children. In any event, while playing the children, compulsorily there should be arrangement of making supervision in the school.

15. Should not be physical punishments to the school children.

16. In every Class permission is issued, there must be ratio of Children and Teachers in every class as per rules. There must be minimum attendance of 25 in each class.
